Manufactured Housing Card Agent Training Class

This course meets the PennDOT Agent Services Training Requirements for individuals handling titling of manufactured homes, only. This PennDOT-authorized course consists of six hours of instruction designed to give in-depth and well organized introductions to the most common transactions and procedures when processing manufactured housing title work.

Card Agents are required to be trained one year after initial licensing and every two years thereafter. Registration includes, lunch, refreshments and a certificate of completion.
