HUD Manufactured Housing INITIAL Installer Training

This training will discuss the proper installation of new manufactured homes, record keeping and other installer responsibilities as they relate to the HUD Administered Manufactured Home Installation Program.

Successful participants will have satisfied the INITIAL training requirement for the HUD issued installer license.

Once licensed the HUD Installer License must be renewed every 3 years. In order to renew the HUD-licensed installer must take 8 hours of approved continuing education.
